

<ul> <li>Statutory Responsibilities</li> <li>The Designated Safeguarding Lead (Nathanial Eatwell) is expected to: <ul> <li>Manage Referrals</li> <li>Liaise with the LADO where concerns involve Professionals (including members of staff)</li> <li>Develop and amend Policy</li> <li>Act as a point of support in all Safeguarding areas for all staff</li> <li>Oversee staff training</li> <li>Raise Awareness</li> <li>Arrange Transfers of Safeguarding Support at all times during the school week and school terms</li> </ul> </li> </ul>	<ul> <li>Wider Responsibilities</li> <li>Manage use of CPOMS system</li> <li>Develop networks with partner agencies and charities</li> <li>Respond to emerging or engrained issues in the community</li> <li>Liaise with Education Partnership trust DSL's to develop a trust wide approach</li> <li>Promote efforts of the school to parents and wider community</li> <li>Arrange supervision for team members or staff in need</li> </ul>	<ul> <li>Day to Day Responsibilities</li> <li>Ensure access to CPOMS</li> <li>Monitor logs made by staff</li> <li>Triage Cause for Concerns logged</li> <li>quality assure logs made</li> <li>Support pupils and staff with emerging concerns</li> <li>Provide staff with updates of concerns or information impacting on teaching and learning</li> <li>Where needed refer to Children's Social Care and/or the Police</li> </ul>
